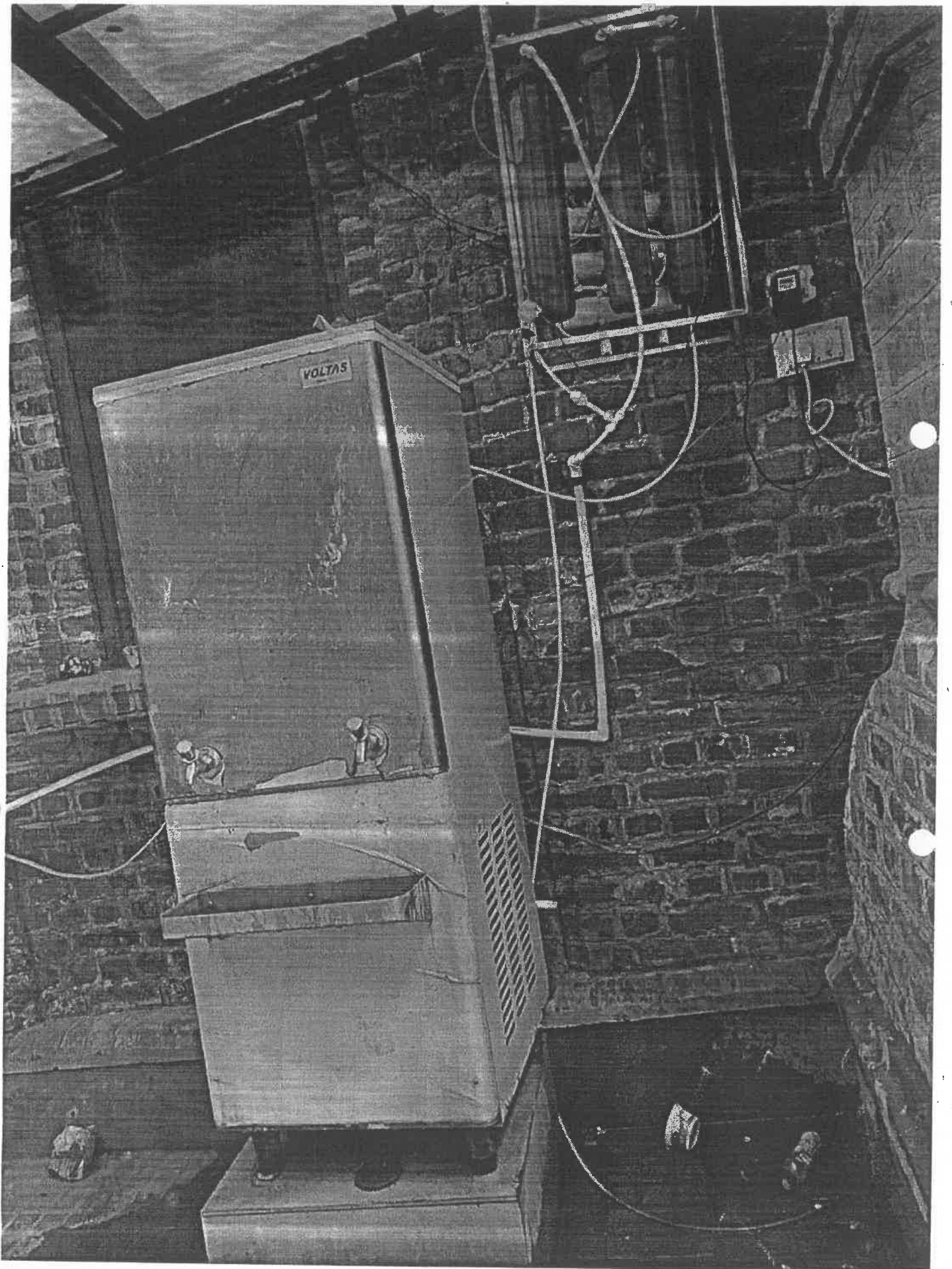

Note: Please don't put plastic foil paper inside the Machine



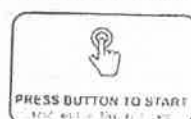
**SANITARY NAPKIN INCINERATOR MACHINE**




